1. Headwaters Livestock Auction LLC, Copper Spring Ranch LLC, Equine Boosters of MSU and their associates and employees act as agents only on all sales, and are not responsible for buyer/seller error or misunderstanding.
2. Consignment forms **MUST** be accompanied by the consignment fee of \$150.00, original registration papers, signed transfer, breeders certificates (if applicable), and quality color photographs (hard copy and JPEG, as well as a video on DVD (+/-) can be played at the sale). **The consignment/catalog deadline is March 15, 2010 at 5:00pm (no exceptions)**. Check to be payable to Equine Boosters of MSU for the consignment/catalog fee.
3. All horses **MUST** be broke to ride.
4. Individual **NEGATIVE COGGINS TEST** (original, not copy) current within 6 months and a Health Certificate within **72 hours of arrival** at Copper Spring Ranch must be turned into the sales office when consignments arrive. No horses may unload on site until all Coggins tests and health certificates have been checked. All paperwork must be turned into office prior to sale.
5. Horses with any unsoundness or bad habits (Example: Cribbers, Parrot Mouth, Lameness or Unsoundness, etc.) are not eligible for entry in the sale. ALL sale horses will have a preliminary vet check on May 1st after they are checked in. The vet check will be done by All West Veterinary Hospital. Under no circumstances will Copper Spring Ranch, LLC or Equine Boosters of MSU be held liable for any finding or any issue. If a consignment horse is found to be unsound, it will be dismissed from the sale, which will be handled by the Sale Management (Headwaters Livestock Auction LLC).
6. Consignors' checks will be mailed after 5-7 business days from the date of the sale.
7. Consignment/catalog fee will be \$150.00 and commission is 8.0% of the selling price. No Sales or Pass Outs must be stated before the horse leaves the ring. Pass out fee is **\$50.00 or 3 ½ percent** of the final bid whichever is greater. In compliance with our insurance fee (.07 percent of \$100.00 in gross sales) will be assessed as well as a \$3.00 vet inspection fee. NO paper work will be given back until all NO SALE FEES and CATALOG FEES are paid. NO EXCEPTIONS!
8. The consignment fee is **non-refundable**. Consignor agrees not to withdraw entry except for injury, sickness, or death. Consignor must provide the sales company with a statement from a licensed veterinarian prior to the date of sale to withdraw. Consignors withdrawing a horse for any reason other than those listed above will be assessed a \$200.00 penalty to cover advertising and sales expenses. **No alley trading will be allowed.**
9. Transfer fees will be deducted from the sellers check in the case of the double transfers.
10. Horses will be stalled at Copper Spring Ranch on May 1st in outdoor pens. If you would require an indoor stall prior to or following the sale, please contact the Gallatin County Fairgrounds at: 406-582-3270.
